### 2. INTRODUCTION

The idea of the project was born at the end of 2020. The primary concept as a project "WCE.LIFE" was found already at the beginning of 2021, by the summer a clear concept and an approximate architecture of the project ecosystem was formed. Then the painstaking work on the elaboration of the project began. More than 50 people from different countries were involved in the project in order to analyze internal features. regulations and interaction with organizations engaged in areas directly related to the project, in particular medical and social institutions, charitable organizations, companies producing medical goods. The data obtained were generalized and systematized. a unified approach to the Ecosystem developed. At the end of the summer of 2021, the "WCE" token was released, which remained motionless for six months. Now we are ready to offer the world a new transformation of charity that will help millions of people around the world.















## 6. THE SCHEME OF PROCESSING AN INDIVIDUAL APPEAL



### 15. TOKEN BURN



The "WCE" token is the first digital Charity product. For the balance and in the interests of the holders of the "WCE" token, starting from the second quarter of 2024, we will begin its redemption and burning



After 2026 we expect to leave in circulation no more than 30% of the initial offer of the "WCE" Token, as a reminder of the first charity digital produ

The "WCE" token, like the World Charity Ecosystem project as a whole, is not a commercial product; the purpose of the token is to introduce a charity segment into the crypto industry. The "WCE" token is not an investment product or a security. The owners of the token are the benefactors of the project. The token itself is a charity fundraiser. No interest and/or dividends are accrued on the token.

Only personal exchange transactions provide income to token holders.
